BOARD MEETING

1. Approval of meeting minutes

Report by Sheila

- Kudos to the Social Committee for organizing a great trivia night event, and to the Sports Committee about a great curling event.

Report by Stephen

- There's been a flurry of paper renewals arriving in the mail. He processed 178 new renewals this weekend, which should add about \$5k to our account balance.
- There were 86 members noted as active on the website on the day of the meeting, which isn't a total count, as he's still processing the manual renewals / applications.

Report by Sofia

 - Food was included in the ticket price, so with food and prizes we probably lost about \$300. At the next event, we might get less food to come out closer to even.
- The committee met to set dates for our next dinners. We are looking at April 9 for the Spring Dinner, and looking at a new option for that event, Ithaka's Greek Restaurant. It's a nice space. The committee will confirm with them in about a week, and if we do not book with them, then we will go with the Hotel Grand Pacific.
- The Summer Dinner will be held at the Inn at Laurel Point in July.
- And then the AGM and Dinner will be held in early November, and the Holiday Lunch in early December. The committee is work on getting us the dates we want.

Report by Marlisa

- Received request we get annually for the Battle of the Bar Bands, requesting \$2,500, which Marlisa believed was the same as requested last year. Proceeds go to the Benevolent Society. They were able to donate \$17,000 last year. We've always gotten behind that.
- There is also a group wanting to put an Immigration and Refugee 101 together to help those wanting to do pro bono work for trans families wanting to relocate from the US.
 Selina wrote back to them to get more specifics about the intended use of the funds (e.g., do they intend to pay an immigration lawyer to do the training, pay for a venue, etc.?)
 - Selina spoke with the person and they discussed potentially doing an Inns of Court virtual training session.
- Battle of the Bar Bands Mar 28 same amount donated to them in the past their proceeds go to the benevolent society, we've always gotten behind that

 - k. Newsletter (Jim Legh/Geneva Houlden)
 - i. Next newsletter: March 1

Report by Geneva

- At the time of the meeting, the content provided to her and Jim was barebones, but enough to put something together. Additional content requested, including the President's sentence, the CBA report, and the UVic update
- Aiming to distribute it for March 1, subject to Geneva's health

Discussion on Letter to the Editor

- Geneva noted that a member of the board (Selina) wrote a letter to the editor, because
 we have an opinion section of the newsletter and have included opinion pieces before.
 The Executive recommended that this be brought to the board for discussion, with
 regard to this letter and how we should approach such opinion pieces generally.
- Selina, as the writer, explained that the letter asks members of the Victoria bar to write
 to the Minister of Immigration, Refugees and Citizenship Canada, copying the Member
 of Parliament for Victoria, calling on the Minister to withdraw Canada from the Safe
 Third Country Agreement with the US, which requires refugees coming to Canada from
 the US to be returned to the US, in light of the changed circumstances in the US.
- Sheila summarized by stating that the question is whether we as a board want to allow letters to the editor that are of a legal nature but that do not necessarily impact lawyers' ability to do work.
- Sofia noted concerns not with the content but with it being a call to action to members, which implies support of that position. The issue she struggles with is not so much about the member's opinion, but about the VBA's endorsement of opinions put forward by

- members via the newsletter. She's not sure if the VBA has taken such stances. She asked those who have been on the board longer to comment on that.
- Clare noted that apart from the content of the letter, if we are going to open the
 Praecipe up for letters to the editor, which she isn't inherently opposed to, we need to
 be clear about the guidelines both for submissions and editorial guidelines. That needs
 to be clearly communicated before just having one out there where people don't know
 that's an option or that that may be coming.
- Darren noted he has some nervousness about this, that he likes Clare's idea about
 guidelines, but has concerns that it could turn into a slippery slope which he's seen in
 numerous situations where if perhaps we don't disagree internally people who we're
 applying the guidelines too may disagree and we would get accused of fettering
 freedom of expression, which would be avoided by not providing such a platform. He's
 not sure where he stands but is concerned about the prospect of us being criticized for
 being selective.
- Clare noted that effectively Jim has been doing letters from the editor for years, sharing his own personal opinions as the editor. So, it would be inaccurate to say that there have not been views expressed, some of which individual members may have agreed with and some of which they may not have agreed with.
- Sheila pulled up a copy of the Praecipe and we do invite comments from the public, which are to be emailed to the editor. While we have had comments from the editor, they're usually looked at by the board and we've had discussions with the editor before about the wording to be clear it was coming from him and other changes. Another concern she has is if we include an opinion piece and it's not clear to the bar that they can do that, it could be a concern to other members if we published a board member's letter without that opportunity first being clearly opened to all members. She added that another concern is that we usually keep the Praecipe to being about lawyers and advocating for lawyers, and a general opinion piece may not fit that criteria.

- Geneva agrees with the discussion so far, but noted that since she's been involved with the Praecipe, we have solicited opinions from the public but no one has taken us up on that before. Here we wrote that we long for the days in which people used to send us things, and then someone did. Her thinking is that so long as we're clear that this is an opinion piece received by a member and does not necessarily reflect the views of the VBA, as long as it's not something like hate speech, it's within the VBA's mandate to provide a platform for that opinion and then in a subsequent issue someone can provide an alternate opinion. She also recognized that it could be a slippery slope in deciding what can get published and not.
- Stephen noted that from his recollection Jim may have put in a parenthetical comment maybe slightly teasing people in a playful way.
- Sheila noted that he put in his own lengthy opinion pieces re the new legal professions legislation
- Geneva noted that in a recent version we copy pasted an article from the Globe and Mail, so not unheard of to reproduce content not by a member or about the legal profession
- Danielle noted that there was at least one time a comment made by the editor prompted people she knew to reach out to her to get clarification if those statements represented the VBA's position.
- Sheila suggested we table this discussion until Jim returns as his knowledge and perspective could help shed some light on past practice and after Geneva and Jim can discuss.
- Clare shared that her point about it being important to have clearly communicated guidelines stands regardless of whether Jim and Geneva want to change anything because we're already inviting comments. She noted that she's in favour of the piece being included but not in favour of us deciding on an ad hoc basis depending on how we feel about it as a board. We should try to come to the next meeting with proposed guidelines.
- Geneva added that we are currently calling for such comments, so if we're not prepared
 to receive them until we develop the guidelines, we should remove that call for
 comments in the interim.
- Sheila noted that guidelines should either be proposed by a subcommittee or by Jim and Geneva to the board.
- Geneva noted that she thinks the latter is best in the circumstances, that she will discuss with Jim upon his return, and put together a draft framework for review at the next board meeting.
- Sheila asked if anyone else wanted to be part of that discussion with Geneva and Jim.
 - o Jessica and Clare put themselves forward to participate in that process.
 - Selina put herself forward for participating in that with respect to other pieces.

- Jim returns on March 13.
- Jessica asked about the call to action part of the letter, if we as a board frequently look at doing calls to action and taking positions on issues like this.
- Sheila noted that previously we had a call to action about the new legal professions legislation, which she believed included the option to attend an event to discuss as well as letter writing. That's the only other call to action she can recall in recent years.
- Geneva noted that another option is to take out the calls to action and make it clear that the letter reflects the views of the writer not necessarily the VBA.
- This matter was referred to the subcommittee and tabled to the next meeting.
